

# INGENIUM PHOTO CHALLENGE: RULES AND SURVEY

## 1. Purpose of the challenge

Bringing together INGENIUM universities in a cultural challenge on the themes of the Rouen edition: sport and health on campus.

The selected photos will be printed and displayed during the 10 days of INGENIUM which will take place in Rouen from 27 to 31 May. During 5 days, participants in the 10 days of INGENIUM will be able to vote for their favourite photo. The first three pictures will win the INGENIUM challenge and a (non-financial) prize.

## 2. Dates

**From 4 April to 29 April 2024.**

## 3. Who can take part and how?

Anyone over 18 years old, studying or working at an INGENIUM university and who wishes to take part may do so, as long as the conditions are met.

Only 1 photo can be submitted. The University of Rouen Normandy may perform any verifications required to ensure compliance with these rules.

Participation in the competition implies full acceptance of these rules. Instagram is not the organiser of this photo challenge and cannot be held responsible for any problems relating to the challenge.

Following the launch on **4 April 2024** on INGENIUM's and the universities' LinkedIn and Instagram social networks, the challenge will run until **29 April 2024**.

Participants must share a photo of their campus on their Instagram account with a theme of sport and health. The photo must be in colour and in square format, 1080 x 1080 pixels (1:1).

## 4. To be taken into account :

- The @univ.rouen account must be identified and #univrouen tagged in the description in addition to the hastags #INGENIUM #EuropeanUniversity #challenge #10DOI
- The @ingenium\_univ account must be invited as a collaborator on the photo so that the likes under the photo count as votes.

Participants must send their application form, image rights and use form (p3. and p.4) to **ingenium.photochallenge@univ-rouen.fr** together with the photo in square format, high definition (300dpi) in JPEG format, minimum 3 MB, maximum 15 MB. maximum.

## 5. Important

Any pornographic, racist or xenophobic photos, as well as any photo that denigrates or is likely to harm in any way whatsoever the image, private life, honour, reputation and/or consideration of any natural or legal person is prohibited.

The University of Rouen Normandy and INGENIUM expressly reserve the right to eliminate without justification any photo which does not respect the conditions of validity set out above or which is likely to harm their image.

If people are photographed and recognisable in the photo presented, the photographer must have obtained their authorisation beforehand. INGENIUM and the University of Rouen Normandy will not be held liable in any way for the use of the said photo in the context of this challenge.

No other use will be made of the photos submitted.

The personal data transmitted in the entry form will not be circulated or used for any purpose other than registration for this challenge.
